

**KILZ RATE&WIN SWEEPSTAKES
OFFICIAL RULES
NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE ODDS OF WINNING.

1. **PROMOTION TIMING:** This KILZ Rate & Win Sweepstakes (the "**Sweepstakes.**") begins at 12:01 A.M. Pacific Time ("**PT**") on April 1, 2022 and ends March 31, 2023 at 11:59 P.M. PT ("**Promotion Period**") and will be divided into four entry periods (each an "**Entry Period**").

2. **ELIGIBILITY:** The Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia, who are 18 years of age or older and are physically domiciled in the United States or the District of Columbia as of date of entry. - iii) Complete all of the required information, including a valid email address, and follow the instructions for submitting a Review.

You must follow the online instructions and comply with the "Terms and Conditions" which are available at <http://spr.ly/60051iSoU> and are incorporated herein by reference. Your Review will not be eligible as an entry in Rate & Win if you do not comply with the appropriate Guidelines and Terms of Use. Photos may be included but are not required and must comply with the Guidelines and Terms of Use.
